Treasurer Report

Dues for 2019 are \$444/year. Statements were mailed in January. As a reminder, only one statement will be issued. Payment can be made via cash, check, or by credit cards on our website. To pay your dues online, visit http://www.kingsgate5.com/dues/. A convenience fee of 3% has been included in payments made online with a credit card. Starting in 2020, we transition to annual billing and annual collections.

At the end of 2018, our combined cash and securities totaled \$136,533.33. We ended 2018 with income less than budgeted and expenses more than budgeted. The significant financial projects in 2018 were the resurfacing of the tennis and basketball courts (\$66,000).

Reserve funds remain adequate and we continue to be financially conservative. In 2016, we updated our reserve study. A full copy of the reserve study can be viewed upon request.

At the annual meeting in January, the budget for 2019 was approved. We are projecting a balanced budget with income and expenses totaling \$221,273. Any excess funds will be moved to reserves for future use.

- We are seeing a lot of garbage strewn about on garbage days as garbage cans get overfilled. The lids don't get closed and crows and raccoons can get in them and spread it about. Please think about the size of garbage can you need.
- We are seeing many cars parked on sidewalks, which again impedes the ability of friends and neighbors from using the sidewalk. Please be mindful of where you and your guests park.


